# **Delivery Motorcyclists**

#### **Assessment Content**

#### Introduction

The assessment is based on the following **Six main occupational standards**, furtherly divided into thirty performance criteria as identified by Abu Dhabi Quality and Conformity Council for Delivery Motorcyclists:


- Fitness and mental health
- Familiar with the required and approved standards for the Personal Protective Equipment (PPE)
- Awareness about the safe riding behavior
- Knowledge about checking the motorcycle condition
- Familiar with the actions needed in case of a road crash
- Maximum Working Hours for Vehicle and Motorcycle Drivers

The assessment is carried out onsite at ADQCC - UAC certified assessment center. The assessment center is equipped with relevant technical and physical infrastructure.

#### **Assessment Methodology**

**Theoretical: Twenty (25) multiple choice question** computer-based test, AI proctored with camera and sound detection recording. Duration of assessment is approximately one hour

#### **Online Assessment System**

The Candidate lifecycle including booking, tracking, assessments and certification will be managed through the ADQCC – UAC IT platform. The platform includes a robust credible, reliable online assessment system delivered in multiple languages (*currently implementing English, Arabic, Hindi, Urdu, Nepali, and Bengali*). The system has the following key features:

Interactive User Interface (UI) and User Experience (UX)

- Simple navigation controls, Progress pellets and Questions color coding and Flagging
- Multilanguage, touch UI with Audio, Screen reader compatibility and accessibility



## **Question Authoring and Randomization**

- Ability to author up to 10 question types including multiple choice, picture/audio-based
- Randomized question and answer ordering for each candidate to deter cheating


# **Anti-Cheating Measures**

- Geo-Tagged attendance, Secure login with token-based authentication
- Al based proctoring tools during theoretical exam (Activity Detection, Sound Capture etc.)
- Live proctoring to monitor the online exam and to identify suspicious activities

## **Reporting and Analytics**

- Analytics for performance trends and areas of improvement including comparative analysis
- Custom scoring rules and grading scales, Weightage based Result Calculation

The platform provides easy user defined access to various stakeholders through dedicated dashboards to monitor, approve and track the Program Progress. In addition, the stakeholders can view assessment evidences for each candidate captured during Assessment Journey (*Refer below*)

#### **Assessment Blueprint**

The overall passing percentage is **Eighty percent** (80%) based on the **Theoretical Exam** 

The assessment weightage suggested for each occupational standard with respect to number of questions to be administered in each exam is explained below.

Occupational Standard	Weightage
Fitness and mental health	10%
Familiar with the required and approved standards for the Personal Protective Equipment (PPE)	20%
Awareness about the safe riding behavior	30%
Knowledge about checking the motorcycle condition	15%
Familiar with the actions needed in case of a road crash	15%
Maximum Working Hours for Vehicle and Motorcycle Drivers	10%



## **Element Grouping**

Element groups have been identified across three occupational standards. Each element group consists of a set of clubbed elements based on relevant group of performance criteria and each represents one area of assessment. Questions are categorized according to element groups. A total number of **twenty-five** element groups have been identified.

Awareness about the safe riding behavior	8
Knowledge about checking the motorcycle condition	4
